KA warrants this product to be free against defects in materials and workmanship as follows:

Labor: For a period of two years from date of purchase if this product is determined by KA to be defective, KA at its sole discretion will repair and/or replace the product with a new or rebuilt unit or repair at no charge. After the warranty period, you must pay for all labor and parts charges. Customer to contact KA for an RMA Number beforehand and ship the cleaner with all parts pre-paid with insurance to KA for evaluation. RMA number must appear on the outside of the shipping container. If the cleaner is found to be defective and under warranty, KA will repair/exchange per the above policy, sending the unit back freight prepaid to Customer. If found to be a customer caused problem or abused and outside of above warranty, the Customer will be contacted and will be responsible to pay for freight charges to and from KA plus repair charges at current published repair rates before repairs are executed.

Parts: If a warranty issue, KA to supply at no charge, new or rebuilt replacements for defective parts and/or unit at its sole discretion for a period of two years. After the warranty, standard repair or replacement rates apply.

SERVICE: To obtain warranty service, you must communicate with KA directly, and then once an RMA Return Materials Authorization Number is received, to ship it back in its original carton, or in packaging offering an equal degree of protection, to KA, freight prepaid with insurance. WARRANTY ONLY APPLIES IF A WARRANTY CARD HAS BEEN RECEIVED BY KA WITH 15 DAYS OF ORIGINAL PURCHASE.

This warranty does not cover any units which have been previously altered, repaired, or serviced by anyone other than KA or used with accessories not approved by KA. This warranty does not cover cosmetic damage or damage due to acts of god, accident, misuse, negligence, or modification to any part of the product. All products sold are as-is and may not be error free. The sole responsibility of KA is to repeat the error and replicate it repeatedly, then provide a firmware fix.
